Conditions for participation:

1. I have taken note of the camp invitation/announcement and I agree to the participation of my child.
2. With my signature I assure that neither my child nor any of the persons that it is living with suffered any infectious disease in the past 2 weeks and that there have been no signs for such a disease. In case of any open question regarding possible risks of infection or pathogen shedding after a infectious disease I commit myself to clarification in time by a physician or a health agency.
3. I agree that my child participates in possible sports events like swimming, canoeing, biking and bigger -also several days lasting- hiking tours. I notify any physical harm or defect that would not allow the participation in certain events on the registration form.
4. I agree that my child in the context of the camp participates in age appropriate events normally taking place in a group and after consultation. It also comprises leaving the event venue (e.g. camp site) in smaller groups without supervision as well as spending free time without supervision.
5. In case of a necessary medical treatment the camp direction will immediately contact the legal representatives. In case that contact cannot be established the responsibility of decisions regarding a necessary medical treatment lies with the camp direction or the treating physician.
6. I informed my child about obeying the existing rules of the camp or cottage as well as the instructions of the German Scout Association Saint George DPSG and its staff members. I understand that gross violations can lead to immediate exclusion and that it is my duty to pay for the arising costs (e.g. return trip home).
7. After returning I, or an authorized person, will pick up my child. Therefore the obligation of supervision of the child and youth promotion and its staff members ends at the meeting point indicated by the German Scout Association Saint George DPSG.
8. In case of withdrawal after written registration at least two weeks before the beginning of the event, 50% of the fees is to be paid. Afterwards the full amount of the fee is to be paid.
9. I understand that I am responsible for any damage caused by my child (personal liability assurance recommended).
10. I understand and inform my child, that the youth protection regulations (nicotine, alcohol, curfews for visits to bars and discotheques) are to be respected.
11. I agree on the publishing of images/videos of my child (e.g. on the homepage of the scout club or in newspapers). In order to do so I submit the enclosed declaration.
12. In case one or more clauses of this contract become partially or completely legally invalid, this does not affect the validity of the remaining clauses. The legally invalid clause will be retroactively replaced by a possibly most similar clause in terms of content, which best fulfils the initially intended purpose of the clause.

Agreement upon the usage of photographs and video for reporting purposes of the German Scout Association Saint George DPSG

The diocesan association Rottenburg-Stuttgart of the German Scout Association Saint George DPSG (legal entity: Gemeinschaft St. Georg e.V.) and the person mentioned above agree on the following terms of use of photographs and videos:

1. It is agreed that recordings of the person above mentioned can be made and that they are available free of charge for the German Scout Association Saint George DPSG for purposes of news reporting, for advertising and for usage as defined in clause 2.
2. No limitations regarding content, time and space are agreed for the usage. Unrestricted usage is agreed for the following purposes:
 - Publication in the media of the association (e.g. magazine, newsletter)
 - Publication in the press (e.g. press pictures)
 - Publication online (e.g. Homepage of the association or on the associations pages on facebook, YouTube or Twitter, etc.)
 - Publication on advertising material (e.g. Flyer/poster)
3. The person photographed/recorded agrees to the usage of his or her picture/video for photomontage under removal or completion of image parts or for alienated images (no distortion) of the original recordings.
4. No claim for usage in the sense of the clauses 1 and 2 is established by the present agreement. The person photographed/recorded is allowed to ask the diocesan association Rottenburg-Stuttgart DPSG at any time for the specific use that has been made of the pictures.
5. The person photographed/recorded transfers all rights for the photographs or recordings necessary for the exercise of the usage according to clause 2 to the photographer.
6. The name of the person photographed/recorded will not be published according to data protection. Disclosure for purposes of market or opinion research is not allowed.
7. No remuneration will be paid for the photographs by the diocesan association Rottenburg-Stuttgart DPSG.
8. Changes to this agreement require to be done in written form.

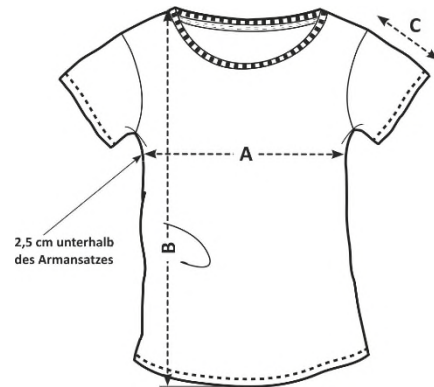

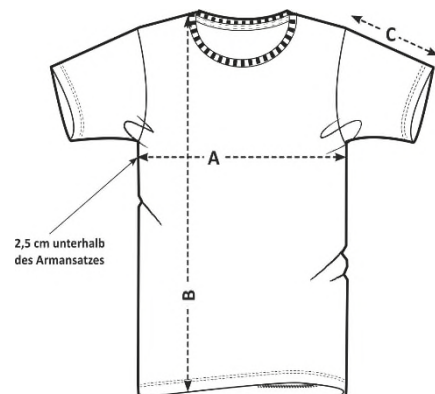
